Located at ESCAPE YFGK
Monday – Friday 9:00am to 2:00pm

Dear Parent/Legal Guardian,

ESCAPE YFGK has developed an alternative program for students who are either suspended or expelled from school. This program provides a safe and educational environment for students while they serve their time out of school. We aim for peace, restoration, academic progress, and holistic growth.

A.S.A.P. is a free program offered to students in the Holland/Zeeland/West Ottawa communities between 6th and 12th grade. Students will need to be reinstated prior to graduation in order to earn their diploma. We recognize that choosing to enroll in the program is not required by the district. We commend your decision to take advantage of these services and are grateful for the opportunity to partner with you and best support your student throughout this sometimes difficult journey. The program is open to all, but is not an obligation for either parties. **Placement in the A.S.A.P. is subject to approval by staff and dependent on program capacity.** Students may be dismissed from the program should their behavior warrant it.

To apply and participate in the program:

1. Parent/Guardian must complete attached forms.
2. Parent and student must schedule and attend an intake meeting.
3. Student must successfully complete "The Bridge" to remain in the A.S.A.P Program.
 - a. The Bridge is an *orientation experience designed to help students make a successful transition into the A.S.A.P Program, contribute positively to the culture while at ESCAPE, and gain essential skills for winning at life*
 - b. The Bridge will be implemented over the first six weeks of attendance for long-term suspended/expelled students. Students with short-term suspensions will complete an abbreviated version over the course of the first day of attendance.
4. Student is expected to follow all rules, expectations and participate in A.S.A.P activities/field trips.

Student Code of Conduct

Safety:

- I understand that possession of **weapons** of any kind on ESCAPE property will result in immediate dismissal.
- I understand that the possession of **medication, illegal substances, alcohol, or vape/dab pens**, on ESCAPE property will result in immediate dismissal.
- I understand that **violence or violent threats** of any kind will result in immediate dismissal.
- I understand that, for the safety of myself and others, I am not allowed to transport other students to and from ESCAPE.
- I will not engage in **public display of affection** or inappropriate touching, whether wanted or unwanted, on ESCAPE property.

Ownership:

- I understand that I will be expected to continue completing assignments & putting forth effort unless instructed otherwise.
- I will accept assignments and tasks **without complaining**, working agreeably with staff & volunteers.
- I understand that I will be expected to be alert throughout the day and need to **be well-rested**.
- I will keep my workspace organized, know my logins and passwords, and **clean up my space**.
- I understand listening to music is a privilege and is only allowed after meeting individual daily assignment goals that are discussed with my ESCAPE Learning Coach.
- I understand that copying test and/or assignment questions from the internet, or another student, is considered plagiarism and is not permitted.

Communication:

- I will communicate with ESCAPE staff when I am not feeling well or needing to "tap out".
- I will not use **offensive language** of any kind.
- I understand that my **cell phone will be collected** at the start of the academic school day.

Respect:

- I agree to abide by these guidelines while in the ESCAPE parking lot, in the ESCAPE building, while using ESCAPE transportation services, and/or on an off-campus trip with ESCAPE.
- I know and agree that **I will not eat or drink in the van** (only water is allowed).
- I will be responsible for my trash in the van and **help keep the vans clean**.

Dress Code:

- I understand that I am not permitted to wear tank tops, muscle shirts, running shorts, pajama bottoms, see through clothing, or clothing that exposes the midriff or cleavage.
- I understand that shorts, skirts, and dresses must extend below my fingertips.
- I understand that I will have to wear my pants at or above the waist.
- I understand that the clothes I wear need to be free from offensive or inappropriate content. I understand that if a staff asks me to change it is because it is violating the dress code and I will need to change into what is provided at ESCAPE or make arrangements in a timely manner.

A.S.A.P. Behaviors & Consequences

The following is a list of common behaviors and resulting disciplinary actions at ESCAPE. Decisions about disciplinary action are subject to the authority and responsibility of the Executive Director or their designee.

Minor Offenses: *These actions are mostly dealt with in the classroom between student and learning coach.*

- Off task (sleeping during work sessions, putting head down, staring off into space etc.)
- Tardiness from lunch, breaks or tap-outs
- Eating inappropriate snacks
- Leaving a mess
- Profanity (mild, first time, not directed at others)
- Mild dress code violation that can be fixed easily and quickly (ie. sagging)
- Blurting out or Interrupting others (inappropriate feedback, comments and questions)
- Distracting others (noises, side conversation, inappropriate comments etc.)
- Not being productive (use discretion)
- Technology misuse (phones and computers)

Non-Negotiables: *These offenses result in an automatic hall conference for first time offense, and for second-time will likely require problem-solving or dismissal for the day.*

- Lying, dishonesty
- Put downs/Mild Insults/Profanity directed at other students
- Unauthorized wandering, habitual tardiness, abuse of tapouts, walkouts
- Destruction of personal property
- Dress code violations (extreme sagging, drug/gang promotion, immodest dress, etc.)
- Rough Housing or throwing objects
- Rude or Unsafe language (disrespectful, argumentative, threatening, or demeaning other students/staff)
- Defiance, Refusal & Noncompliance for a reasonable request (ie. working productively)
- Misuse of classroom resources and supplies
- Cell phone or personal technology used at inappropriate times according to staff's specific expectations.

Dismissible offenses: *Automatic office referral and dismissal for the day (first-time offenses), or permanent dismissal for repeated or severe instances.*

- Damaging property (graffiti, ripping books, willfully destroying ESCAPE or individual property)
- Stealing personal property
- Bullying, Harassment, or Fighting (causing/attempting to cause physical injury)
- Continued Profanity, vulgar or racist language, obscene gestures
- Verbal abuse (name calling, slurs, threats)
- Lying or giving false info to staff
- Scholastic dishonesty (cheating, plagiarism, etc.)
- Willful disobedience/ Persistent defiance
- Repeated interference with a ESCAPE'S ability to provide educational opportunities to other students
- Abuse of computer/technology privileges
- Major or repeated dress code violations



The expectations for student success in the A.S.A.P Program can be summarized by, and will be communicated through the following:

The 6 P's:

1. Prompt: Early is on time
2. Prepared: Be ready mentally, emotionally, and physically to participate and learn.
3. Polite: Treat everyone with dignity and mutual respect
4. Positive Mental Attitude (PMA): Expect a good outcome. Use your words. Manage your anger. Actively work to solve problems.
5. Participate: Education is your responsibility. Own it! Step into the Circle. Be part of the process.
6. Produce: TCB - Take care of business.

Attending Skills:

1. Be in the Moment: Be engaged in your learning.
2. Use Appropriate Body Language: Keep your head up, facing the speaker. No heads on desks. Show you are listening!
3. Use appropriate eye contact.
4. Use appropriate feedback: Show you understand and are engaged. Smile. Nod.
5. Ask questions to clarify or validate.

Attendance:

Prompt attendance at all work sessions and other scheduled A.S.A.P. commitments are required. The learning experience is central to educating young people in the practice of articulating their ideas, expressing understanding, seeking clarification, and absorbing information. Additionally, regular attendance is seen as a clear expression of dedication to the A.S.A.P program and is reviewed as part of their petition to return to their school.

Excused Absences: Students may request permission to miss A.S.A.P. for an outside obligation. These may include but are not limited to court appearances, medical/dental appointments, school hearings or family vacation. ESCAPE Parents and guardians must notify staff in advance via phone call or email.

Students who accrue the equivalent of 3 full days of unexcused absences may be dismissed from the program in order to make their spot available for other eligible students. Prior to dismissal, staff, students, and parents will work to problem-solve the issues leading to truancy.

Truancy Problem-Solving Protocol:

1. One Unexcused Absence - Education Director calls home to notify family.
2. Two Unexcused Absences - Student meeting with Education Director and/or Learning Coach to work through Problem Solving Form.
3. Three Unexcused Absences - Student is considered for dismissal. If dismissed, the student is responsible for setting up a disciplinary hearing if reinstatement is desired.

Van Expectations:

If a student is signed up for ESCAPE Transportation, it is their responsibility to be outside during their designated pick-up time. If the student misses the van three times, they will be removed from the route. This is to ensure that there is not a misuse of ESCAPE resources. To regain van privileges and rejoin the route, students are required to go through Escape's disciplinary process.

Cellphones: All students have been made aware of and have agreed to the cell phone policy. If a student refuses to turn it in when phones are collected at the beginning of the day, or if it is found on the student/in the student's possession, a problem-solving contract will be put in place and parents will be notified. This policy exists in order to limit distractions for students and reduce the possibility of academic dishonesty. Phones are stored securely in the front office.



ESCAPE's Problem-solving Model

Having clear communication and problem-solving through negative and unproductive behavior is at the heart of the work we do with students at A.S.A.P. We recognize that often the behaviors that lead to negative outcomes are because of a lack of skills in communication, conflict resolution, anger, coping strategies and group dynamics. As such, ESCAPE staff employ the following model when negative behaviors arise to provide the student the opportunity to learn from, own, and fix their own problems. It is the expectation that students will be willing to engage in problem-solving their behaviors as they arise, so they may find success in the A.S.A.P. program, their home and in their return to a school community.

- **Step 1 - Redirect**
 - The student will be asked about their behavior in a friendly/discreet way and asked if they can fix it. This is a simple reminder of the expectations and an encouragement to own and change it.
- **Step 2 - Redirect 2**
 - The behavior is named, and the desired behavior is stated. Students are reminded that they agreed to fix it and are given another opportunity to change. It may be combined with proximity to reinforce the expectation, or a change of seating as a way to mitigate it.
- **Step 3 - Hall Conference**
 - The student is asked to step outside the room. The student's behavior is named, and the needed behavior is once again described. Staff will inquire about causes and solutions of the behavior in a friendly and supportive way, giving them the chance to "own their stuff" and brainstorm what would lead to positive change. The expectation to return to the group is stated and the student is left with encouragement to make the changes necessary to remain in the environment.
- **Step 4 - Problem-solving Contract & Removal**
 - The student is asked to leave the environment and work through a problem-solving contract in a different space. This form is intended to give time for extended reflection and dialogue upon re-entry the next day. The form may be sent home for parental signature. Students may be sent home for the day and may only return to the environment after a restorative conversation with commitments and supports in place.
- **Step 5 - Dismissal**
 - If issues continue to arise, the student may be dismissed and scheduled for a disciplinary hearing if reinstatement is desired.



Three Way Commitment

It takes a **team** to make this work. No one wants to be kicked out of school, but we're going to make the best of it we can. By signing this commitment, you agree to doing your part.

Student Commitment

I, _____, understand the rules and expectations and agree to always follow them. I am going to be respectful, ready to learn, safe, and present. I will trust that staff are working in my best interest. My presence will only affect the progress and growth of those around me in a positive way. I will communicate clearly, often, and respectfully with ESCAPE staff and my parent/guardian, knowing that we are all on the same team for my success. I understand that if I fail to follow with the rules and expectations that there will be disciplinary action that could result in dismissal from the program.

I agree that I am solely responsible for updating medical information to Escape.

Before giving consent, please review the Q&A section on this form. This will provide you with usage rules and helpful guidance for you and your student. Thank you for your continued support!

Q. Can I post whatever I want on BAND?

A. No. Escape Ministries is committed to fostering a positive, inclusive, and safe environment for everyone. This means that there are things you **CAN** and **CANNOT** post.

Additionally, ESCAPE staff will monitor and take disciplinary action, including blocking content, redirects, problem-solving sheets, and dismissals, as needed on the BAND platform.

Q. What can I post?

A. We're on a mission to make BAND a true haven of safety, creativity and fun-filled vibes. Join ESCAPE in promoting this community by sharing:

Positive messages, questions, or reflections. For instance:

- "I'm so excited for Camp Beechpoint!" or "What time can I drop-off my child for today's field trip?"
- Captivating videos or pictures that capture your creativity, epic memories of good times, or a snap that's worth a thousand words!
- Remember: Only share pictures and videos that you've taken or have the right to share. Don't post on someone else's behalf. **Permission is key!**

Q. What posts are not allowed?

A. Sharing anything that's shady, tricky, false, or meant for sneaky and illegal activities such as exchange of drugs, vapes, alcohol. Stay on the right side of the law!

Bullying and intimidation is strictly prohibited on BAND as it goes against our policies and values. It is against the rules to register an account, post photos or comments on the platform with the intention of harassing or bullying someone.

Speech that leads to violent or physical harm or spreads false information based on race, ethnicity, national origin, sex, gender, gender identity, sexual orientation, religious affiliation, disabilities, or diseases is absolutely unacceptable.
